## NOTES:

- Vacation periods and terminal examinations may be adjusted by the institution as per academic and administrative convenience, provided minimum INC-prescribed teaching and clinical hours are not affected.
- All Principals and Academic Coordinators must ensure that holiday planning, cultural programmes, or special events do not reduce or interrupt mandatory clinical postings, particularly for final-year and internship students.
- Year-wise distribution of theory, skill lab, and clinical hours shall be followed strictly as per Indian Nursing Council norms and must be maintained through separate attendance registers and hour-tracking records for each GNM year.
- Clinical logbooks, skill checklists, and competency records must be updated regularly and verified by clinical supervisors and faculty as part of continuous assessment.
- Students must achieve minimum attendance and competency requirements in both theory and clinical areas to become eligible for terminal and council examinations.
- Internal assessments, terminal examinations, and model tests are mandatory and shall be conducted as scheduled to ensure academic progression and for calculating internal marks.
- Final-year students shall complete their mandatory internship hours during the Advanced Clinical Exposure phase, in accordance with INC regulations.
- Health observance days, Nurses' Week, and community outreach activities included in this calendar should be utilized for professional development, leadership training, and public health education, without compromising clinical hours.
